SWEEPSTAKES OFFICIAL RULES

1. ADMINISTRATOR AND SPONSORS: The Sweepstakes (defined below) is run by USFRSC, Inc. dba *Cowboys & Indians* ("Administrator"), 6688 N. Central Expwy., Suite 650, Dallas, TX 75206. 2. 3. DEADLINE: Online entries must be received between 12:01 a.m. Central Standard Time on June 5, 2018 and 11:59 p.m. Central Standard Time on July 24, 2018 (the "Entry Period").

4. LIMIT OF ONE ENTRY PER PERSON. Only one entry is permitted per person. This means that you, personally, can only enter once per Entry Period.
